Prolonged suspension in a harness can be fatal. It is important to exercise the legs by pushing against the tree or doing other forms of continuous leg exercises to avoid blood pooling while being suspended. Varying degrees of physical fitness may require different plans for self-recovery/escape to minimize the effects of prolonged suspension. Have a personal plan and practice it in the presence of a responsible adult before leaving the ground. No one escape/rescue plan will work for every hunter, on every tree, in every circumstance. Only you can determine the best self-recovery/escape plan for your hunting situation and you must have a self-recovery/escape plan for your individual situation before leaving the ground. There is time to make a correct decision on what action to take if a fall occurs while wearing a full-body fall arrest harness. It is important to remember, "DO NOT PANIC." You must only hunt from the ground when self-recovery/escape ability is absent. Failure to follow these instructions may result in serious injury or death!



WARNING! A suspension relief device must be on your person and readily accessible while using a harness. These devices allow the user to relieve the load on the lower extremities if suspended in a harness and help maintain circulation in the legs, mitigate suspension trauma (blood pooling) or allow descent to the ground. Be sure to follow the manufacturers' directions on the safe use of any suspension relief device. Several optional products/systems are available that offer self-recovery or self extraction from a fall when suspended in a harness. Some systems automatically descend the user while others allow user control. One of these products/systems can be considered for use as an additional safety precaution against prolonged suspension and suspension trauma. Be sure to follow the manufacturers' directions on the safe use of these products/systems. Failure to follow these instructions may result in serious injury or death!

(HANG-ON OR LOCK-ON) TREESTAND USAGE FOR NON-CLIMBING TREESTANDS



WARNING! Correct tightening and adjustments of cables, straps, etc. are critical to stable hang-on or lock-on treestand installation. All treestand contact points must be in contact with the tree before you step onto your stand. Failure to follow these instructions may result in serious injury or death!



WARNING! Practice the attachment of hang-on or lock-on treestands at ground level before using in a hunting environment. Failure to follow these instructions may result in serious injury or death!



WARNING! Never leave a treestand in a tree for more than two (2) weeks (14 days) as weather and/or animals could cause damage. Tree growth can also stress and damage straps, chains and buckles. Failure to follow these instructions may result in serious injury or death!



WARNING! Climbing aids (e.g., ladders, climbing sticks, stacking steps, etc.) must extend above the treestand standing platform (at least 24-inches [61cm]) to allow the user to step down onto the platform. Never step up to your stand from a climbing aid. Failure to follow these instructions may result in serious injury or death!



WARNING! Use a hoist rope to raise and lower the treestand. Never climb with anything on your back. Failure to follow these instructions may result in serious injury or death!



WARNING! ALWAYS have a second adult present or at least accessible by cell phone or other means when installing/removing or using a tree stand. 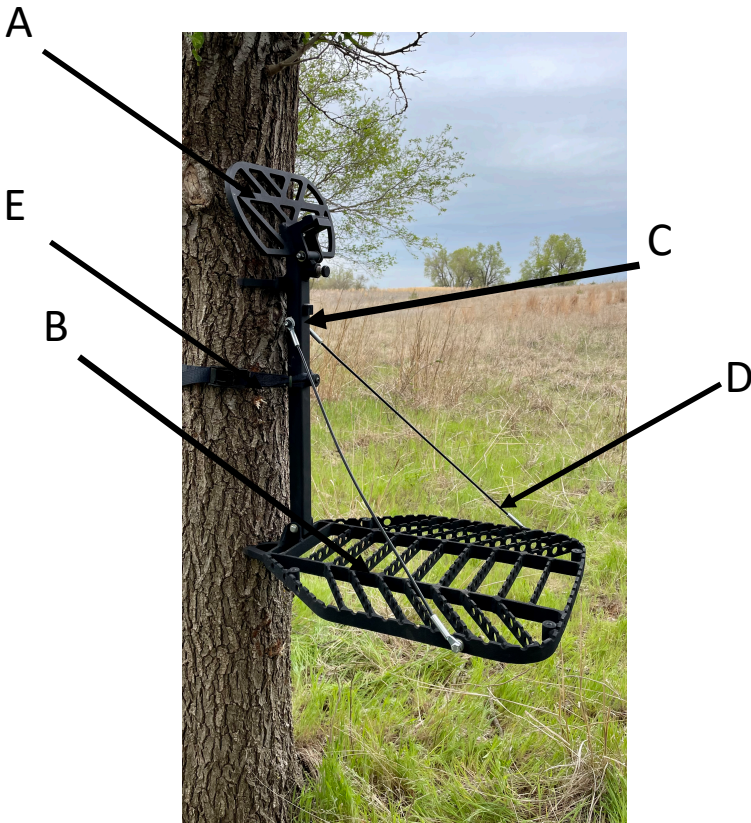

ADDITIONALLY, YOUR NEW FULL-BODY FALL ARREST HARNESS MUST BE REPLACED AFTER FOUR (4) YEARS OF SERVICE! REPLACE YOUR HARNESS IMMEDIATELY SHOULD YOU EXPERIENCE A FALL WHILE WEARING IT.

Attaching Your Stand to the tree



It is extremely important for your health and safety to maintain 3 points of contact and to wear a harness at all times while hanging and hunting from a tree stand. You will want to attach one loop of the strap to the top-hat button before hanging the stand. Once, you have attached the strap and put on your safety harness you will want to start with the stand in this position.



With one end of your pull strap attached, your pull strap buckle needs to have the button portion facing out.



Next, take the other looped end of the strap around the tree then hook it onto the top-hat button.



Pulling the strap to tighten is a very important part of the setup. Pull the tail end of the strap so that the stand pulls snug against the tree. Do NOT over tighten your strap as it could cause unneeded stress. It is important to remember that this stand is intended to cam over with a singular strap.



To cam the stand over all you need to do is simply push down on the platform until the platform is in a level position. You will notice the strap has become tighter and your stand is firmly seated against the tree. Located at the top of the HUSH post is a knurled knob. This knob can be turned to micro level your platform as well.



Once your platform is level your stand should look similar to this figure. It is extremely important for your health and safety to maintain 3 points of contact and to wear a harness at all times while hanging and hunting from a tree stand.

Using your seat as a load-out shelf



You will notice located under the seat is a small knurled knob. Just loosen that knob a few small turns and pull along the track to slide the spacer out. This will allow your stand to fold backwards to a 90 degree angle for a load out shelf.
